## Instructions for Successful Candidates:

- 1. The offer of admission is subject to statutes, regulations, and rules of IBA Karachi as specified in the Program Announcement 2025-26.
- 2. The fee structure is currently available on IBA's website https://www.iba.edu.pk/fee\_structure.php.
- 3. The Admission Package, including Admission Offer Letter, will be sent via email to the applicant on the email ID mentioned in the application form by the candidate, during the April 2025.
- 4. Admission cannot be deferred and the Admission Offer would be valid for Fall 2025 only.
- 5. Successful candidates must pay semester and enrollment fees through a bank challan, enclosed in the admission package, in designated branches of the Banks by April 2025. Non-Payment of this fee would nullify the Admission Offer.
- 6. After depositing the prescribed fee, the candidates are advised to visit the Program Office Main Campus. Additional information about document submission would be available in the Admission Offer Letter.
- 7. Candidates whose last degree was not business related (e.g., BBA, BS ACF, BS Management Science) will be required to take 2-3 weeks of Business Orientation Program (BOP), before the start of Fall 2025 semester.
- 8. The schedule to attend the Business Orientation Program 2025 will be emailed at a subsequent date.
- 9. Successful candidates are also required to attend an Orientation Session' scheduled to take place at 9:00 am from August 21 23, 2025, IBA Main Campus. Attendance in the Orientation Session is compulsory.
- 10. Fall 2025 Semester classes will commence from Monday, August 25, 2025.
