- 3. The Admission Package, including Admission Offer Letter, will be sent via email to the applicant on the email ID mentioned in the application form by the candidate, during the last week of July 2025.
- 4. Admission cannot be deferred and the Admission Offer would be valid for Fall 2025 only.
- 5. Successful candidates must pay semester and enrollment fee through a bank challan, enclosed in the admission package, in designated branches of the Bank by Friday August 15, 2025. Non-Payment of fee would nullify the Admission Offer.
- 6. After depositing the prescribed fee, the candidates are advised to visit the Program Office Main Campus. Additional information about document submission would be available in the Admission Offer Letter.
- 7. Successful candidates are also required to attend an 'Orientation Session' scheduled to take place at 9:00 am from August 21-23, 2025, IBA Main Campus. Attendance in the Orientation Session is compulsory.
- 8. Fall 2025 Semester classes will commence from Monday, August 25, 2025.
