

Syllabus for the post of Sindh Sales Tax Officer (Trainee)

The curriculum for the Accounting, Economics and Public Finance covers the topics that are covered at graduate level of studies. However, the depth of coverage of topics is lesser than advance level and to an extent of introductory to the intermediary level of graduate studies. Topics related coverage is definition of accounting, usage of accounting information, principles, and concept, measuring and recording of business transaction, adjusting entries, accounting equation, completing the accounting cycle, accounts receivables etc. There are many books that cover these basic topics in accounting among them are Accounting Principles, 14th Edition Jerry J. Weygandt, Paul D. Kimmel and Financial Accounting by Meigs & Meigs, Bettner, Whittington, 9th Edition.

Similarly, in the economics the basic knowledge of the field is tested. Such as, the candidates understand the working of the economy, the use of market, law of supply and demand, cost and benefit analysis, production, and market structure at the firm level. Macroeconomic issues regarding interaction of goods and service markets, labor and money at aggregate level. The role of government policy to address microeconomic market issues and macroeconomics objectives. Any graduate level economics books will cover these topics one of such famous book is Economics by Paul Samuelson and William Nordhaus, 19th Edition. In the Public Finance, the role of government in the economy for the betterment of the individual and corporations, the provision of the public goods, cost-benefit analysis, public expenditure, bureaucracies, and the principles of government finance. Although the coverage of the topics will be less intense than provided in the book of Public Finance by the David Hyman, 10th Edition.

Lastly, the examination portion on the Mathematics, Logic and English gauges the skills of the candidates with the benchmark skills required for the admission into graduate level studies. Mathematical section will test the knowledge of fundamental mathematics and will be in line with curriculum of SAT/GMAT. Logical section will assess the general competence, critical reasoning and thought process of the candidate. English section will be based on SAT/GMAT pattern and will assess the grammatical and vocabulary knowledge of the candidate. General Knowledge including global business affairs will test the general knowledge of political and business affairs of the candidates. Overall, the difficulty of the questions will be of standard aptitude test (SAT/GMAT).
